- Cllr D. Harman thanked ex Cllr Linda Golding for all she had done and accomplished for the Ward of Herongate and Ingrave and West Horndon. He then welcomed new Cllr Jo Squirrell.
- Cllr Harman addressed an email from a resident, who was unable to be present, regarding reduced street lighting. Cllr R. Hirst explained the savings in revenue to ECC and said that feedback had been positive. Others felt that in some areas, due to personal safety issues, street lights should be reinstated. Another issue highlighted by this resident was the pot holes in Middle Road, Ingrave. Cllr S.Murphy said that the problem had been reported and Cllr R. Hirst asked that Cllr. D. Harman send him the photos of the pot holes. Cllr J. Squirrell also asked for copies of the photos.

Regarding the concerns of the resident in Brentwood Road who reported that the pathway at the back of her house was overgrown, I received a copy of an email from Dawn Taylor, BBC on 1st May advising that the problem would be dealt with that day. However at the time of writing the work has not been carried out and Cllr D. Harman has now identified the owner of the overgrown hedge who has promised to cut it back.

Regarding the parking problems on the Peartree Pond site, I have now received permission from Lord Petre to put up a 'No Parking' sign.

• 14/15.018 Reports from Councillors

Following Cllr N. Amor's concerns regarding the spraying around posts by Brentwood Council, I have since spoken with Stuart Anderson, BBC, who advised that the chemical is a growth inhibitor. Dawn Taylor, BBC also advised that BBC carried out weed treatment around street furniture throughout the borough. This allow them to lower the risk to parked vehicles suffering possible damage from debris being thrown up by strimmers and complete mowing cycles more efficiently.

Cllr K. Pegram had a meeting on site with ECC Highways who said that it would be in the region of £27,000 to bring the lane up to an adoptable standard. She also made enquiries with other contractors regarding repair and one contractor has estimated £7,065. This item will be on the next Agenda.

14/15.042 Herongate and Ingrave Bus Shelters

Cllr D. Harman advised that BBC has now agreed to fund two new bus shelters and the order process is in hand. The Parish Council will, as previously agreed, pay the balance up to £4,500 to obtain more substantial shelters.

14/15.043 Crime and Disorder

Cllr S. Murphy spoke of the recent restructuring within Essex Police. She also mentioned that youths have been sniffing substances from canisters by the Esso garage and local Pub car parks.

Cllr D. Harman highlighted Planning Application 14/00428/FUL – Button Farm, Herongate, CM13 3PN – to build a pair of semi-detached agricultural workers properties. It was suggested that in order to demonstrate transparency in making any decisions in local matters where a Parish Councillor was the applicant that the Parish Council would hold an Extraordinary Meeting to make a decision. The Clerk was asked to arrange this and post the Agendas.
